Please print this and bring it with you to the event. If you are unable to print this yourself, forward it on to a friend to print for you.

**CANCELLATION POLICY:** Cancelled entries up to 30 days before the event will incur a 10% cancellation admin fee, there are no refunds on entries cancelled within 30 days of the event. After entering if you are unable to attend and you wish to nominate another rider to take your place, you must email [mrcvinfo@gmail.com](mailto:mrcvinfo@gmail.com) no less than seven days before the event. We cannot substitute riders on the day.

MCRCV does not share the personal information of Stockman's Rally entrants with any external third parties.

## CONTRACT TO PARTICIPATE IN THIS MOTORCYCLE EVENT

Please read the following indemnity information and either **DECLINE** or **ACCEPT** the conditions in order to proceed further.

1. **I HEREBY AGREE** with the persons, organisations and bodies corporate whose names appear in Schedule 1 (hereinafter collectively called "the organiser") that I am by this agreement entitled to participate in the motorcycle activity/event listed in Schedule 2 (hereinafter called "the event") at the venue listed at Schedule 3 (hereinafter called "the venue") on the terms and conditions set out in this document.
2. **I ACKNOWLEDGE** that motorcycle riding is dangerous and that by engaging in and participating in this event I take and am exposed to certain risks and dangers and am under certain obligations as follows:
  - a) that I may be injured, physically or mentally, and may be killed;
  - b) that my machinery or equipment may be damaged, lost or destroyed;
  - c) that other riders may ride dangerously or with lack of skill;
  - d) that track or event conditions may be hazardous and may vary without warning or predictability;
  - e) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time and/or events;
  - f) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
  - g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
  - h) that I have an obligation to myself and to others to ride safely.

## **INDEMNITY GIVEN TO ORGANISERS**

**3. IN CONSIDERATION of the acceptance of me as an entrant in the event I AGREE TO INDEMNIFY the organisers and each of them in the following manner:**

- a) that I participate in the event at my sole risk and responsibility;**
- b) that I accept the venue as it stands with all or any defects hidden or exposed;**
- c) that I indemnify and hold harmless the organisers, their respective servants, agents or officials against any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of my death or any injury loss or damage caused to me or to my machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.**
